Summary of Experience

Twenty-three years of post-doctoral experience in research on Agricultural Extension, Agricultural Innovation Systems and Programme Evaluation. Managing and co-coordinating research programmes in South Asia; Member in national and international policy think tanks. Three years of experience as the Chair, Steering Committee of the Global Forum for Rural Advisory Services (GFRAS).

Main areas of research include agricultural extension systems and policies, application of the innovation systems framework in agricultural research and extension, role of private sector and public-private partnerships in agricultural research and extension, developing new approaches to reaching rural women and evaluation of ICTs in agriculture.

In 2012, led the drafting of the “The New Extensionist” Position Paper for the GFRAS and in 2008, co-authored the South Asia Regional Agricultural Research Strategy Document for DFID. Contributed to the development of Country Programme Framework (CPF) document of Government of India-FAO in 2012-13 and authored the chapter “Knowledge Generation and Management” for the Government of India-FAO National Medium Term Priority Framework (NMPF) in 2008-09. Apart from these, has published several research papers in national and international journals and has contributed several policy papers, policy briefs and discussions papers on research, extension and innovation management. Currently also serving as an Associate Editor of the *International Journal of Agricultural Education and Extension* (IAEE).
