The process of customization allows existing material to be adapted and/or further developed to suit different contexts. The material can be customized for training in a face-to-face set up, online, or both; or it can be modified to be integrated into mainstream programs or curricula of training institutions. ## **Global Good Practice Notes**



#### **Innovation Platforms**

Farmers, agri-business and service providers have to innovate continuously to adapt to an everchanging environment (including markets, climate and resources). Innovation is about putting ideas that are new to a certain location into practice, and in this way changing the situation of those living in this area for the better. These "ideas" can be a new way of irrigating a field (i.e. a technology), a new way of organizing women farmers to bulk their produce (i.e. an organizational innovation), or a new policy that supports smallholders in getting bank loans (i.e. an institutional innovation). In agriculture, innovation often involves a combination of these different types of changes.

#### How to NOT promote farmer producers organizations - lessons learned

While mobilizing farmers into Farmer Producer Organisations (FPOs) is an important strategy to double farmers' income, promoting this approach widely without sound planning can lead to exactly the opposite. Thamban C, in this blog, offers several lessons on how to not promote FPOs by drawing experiences with coconut FPOs in Kerala.

## **GFRAS Impact Stories**

Australia's Great Barrier Reef is the largest living structure on Earth. The ecosystem

supports a rich biodiversity, but is facing numerous challenges to its survival, including climate change, ocean acidification and pollution. Runoff of sediment, nitrates and pesticides from farms in the catchment area is a key issue, but farmers currently lack

an effective agricultural extension service.

In response to the need for better advice on more sustainable options, the Great Barrier Reef Water Science Taskforce in collaboration with Australia-Pacific Extension Network (APEN), the regional GFRAS Network, initiated a project in 2018 to improve the delivery of extension services through better coordination of actors and a clearer career pathway for extension professionals.

The key strategy is to build experience and support networking through a work placement programme. This will attract new trainees and ensure continuity of service in the years ahead. The trainees undergo year-long work placements in suitable host organisations, where they receive relevant technical training and personal mentoring from experienced advisers. The programme has provided an effective pathway for people coming into the industry to develop their skills and APEN has now plans to further develop its mentorship programme.

The Argentine Association of Rural Extension (AADER) is a non-profit organization founded in 1983, whose purpose is the integral development of rural extension in Argentina. Since then, it has been continuously carrying out different actions aimed at improving Rural Extension in the country, serving also as a meeting and discussion forum for extensionists.

From 2015, RELASER - the Latin American GFRAS regional network - is associated with AADER to energize its activity in Argentina, taking advantage of this instance of debate and articulation around rural extension already positioned.
